1. Welcome

1.1 The Chairman welcomed everybody to the meeting including Borough Councillor Pope and Mr. Tim Spooner (Chairman of Nordelph Village Hall Committee).

2. Apologies

- 2.1 Apologies were given as listed above and accepted.
- 3. Declarations of Pecuniary Interest & requests for dispensations
- 3.1 No declarations of pecuniary interest were made and no dispensations were required.

4. Public Forum

4.1 The meeting was suspended to hold the Public Forum.

Two residents of Silt Road were present interested in being co-opted onto the parish council to fill two of the three vacancies. Following introductions from both of them it was resolved with all in favour to co-opt Mr. Scott Lansdell-Hill and Mr. Paul Dawson, both residents of Silt Road onto the parish council.

Mr. Spooner was attending to contribute to discussions surrounding Item 9 on the agenda – to discuss Village Hall matters.

5.1 It was resolved to accept and sign the Minutes of the last meeting as a true record of the meeting.

- 7.3 It was resolved with all in favour to purchase a dog waste bin to be located close to the cemetery at Birchfield Road. Clerk to confirm exact location with Highways.

9. Village Hall

- 9.1 In the absence of Councillor Free, members were unable to discuss potential costs associated with the conversion of the space upstairs at the village hall to a rentable flat but concerns were noted regarding compromising the village hall's charitable status, insurance and business rate implications. To be deferred to the November meeting.
- 9.2 A key for the storage room downstairs at the village hall was passed to the Clerk.

10. Police Matters

10.1 Clerk to determine whether or not the Police have visited Silt Road yet or not to carry out speed checks.

11. BCKLWN Issues

11.1 It was noted that the Borough Council's 2018/19 Consultation for their *Council Tax Support Scheme* is now open for comment by all residents of the Borough. This is accessible via the parish council's website.

12. Norfolk County Council issues including highways

- 12.1 The SAM2 camera is currently in the parish. Councillor Dawson and Councillor Lansdell-Hill to take over the running of the SAM2 camera at Silt Road.
- 12.2 Clerk to report a loose manhole cover on the A1122.
- 12.3 Clerk to follow-up the cutting back of overgrowth from properties at Birchfield Road.
- 12.4 Clerk to report to the Middle Level Commissioners overgrown brambles on the riverbank at Birchfield Road.

13. Planning

13.1 To note **Planning Application 17/01171/F,** flat roofed single storey extension to rear of existing property at 2 Thorpe Terrace, Silt Road, Nordelph – approved by the parish council.
