- 4.1 There were no members of the public present.

- 5.1 It was resolved to accept & sign the Minutes of the last meeting as a true record of the meeting.

This is to be backdated to 1 April 2016. This is an increase in 38 pence per hour, £6.02 per calendar month (£192.66). The same notification advises that the hourly rate is to be increased to £12.161 as of 1 April 2017.

11. BCKLWN Issues

- 11.1 Details of the seven week public consultation commencing 8 July regarding devolution were noted. There is an on-line survey on the Norfolk County Council website which residents are being encouraged to fill out.
- 11.2 There is a *devolution briefing* meeting for parish councils at the Town Hall in King's Lynn on 12 July 7pm to 8.30pm.

12. Cemetery

- 12.1 Reverend Burnett-Hall had been notified of the wobbly headstones in the churchyard following the risk assessment on 18 May.
- 12.2 The one relevant party involved had been notified of a wobbly headstone in the cemetery 3D.
- 12.3 It was resolved to accept the quotes from Thomas Bonnett to re-hang the gates at the cemetery (£566.66 + VAT) and to re-paint the gates (£625.00 + VAT).

13. Norfolk County Council issues

- 13.1 It was noted that the overgrown hedge on the corner of the A1101 has now been cut back.
- 13.2 Data from the SAM2 sign had been downloaded and was considered. Clerk to investigate to whom the data should now be sent to at Norfolk Constabulary. Initial findings surprisingly were that traffic did not really seem to increase too much during the beet season but that speeding is definitely an issue along Silt Road, being worse at certain times of the day.
- 13.3 Clerk to investigate quotes for *village gateway signs* for the village to be possibly purchased with a grant via the 2017/18 Norfolk County Council Parish Partnership Scheme.
- 13.4 It was noted that the Rangers will be visiting the parish week commencing 1 August 2016.
- 13.5 Clerk to report the damaged highways speed restriction sign along the A1101.
- 13.6 Clerk to report a pot hole on the brink of the bridge with the A1101.

14.1 It was resolved to *approve* planning application 16/00886/F construction of a 6 metre long timber mooring with bankside steps at Hawthorn House, Birchfield Road, Nordelph.
