- 8.2 Income since the last meeting was noted at £0.00.
- 8.3 The 2017 2018 budget figures were considered again. It was noted that the *Internal Audit fee* will possibly double next year due to the current auditor's retirement and previous very keen charges. Charges for the *website* and *British Telecom* may be slightly more than budgeted for due to recent transparency code requirements from central government. Electricity charges for energy usage and maintenance could reduce if the four lamps in the parish are swapped for LED lamps from sodium on going.

Councillor Gott and Councillor Free to make their mobile telephone numbers available to the Police to receive these texts with details of suspicious vehicles in the Downham Market area to enable them to forward on to interested parishioners.

11.1 Clerk to put forward *Nordelph Village Hall* as a worthwhile local community project to benefit from any available funding from the *West Norfolk Green Points Scheme*.

## 13. Norfolk County Council issues

- 13.1 It was noted that the bid for *Village Gateway Signs* had not been progressed as Norfolk County Council were now only progressing schemes using composite gates, not wooden. Composite gates were far too expensive for the parish council to pursue.
- 14.2 Clerk to follow up with David Mills with the cost of a 'kit' bridge to complete footpath 7.
- 14.3 It was noted that there are a few trees and shrubs along Birchfield Road overhanging from private properties that need cutting back. Clerk and Councillor Gott to action by writing to those residents concerned.

## 14. Planning

14.1 Planning Application 7/00972/F, Conversion of outbuilding to annexe at Whitehouse Farm House, Outwell Road, Nordelph – approved by the parish council.

### 15. Correspondence

15.1 It was noted that the Upwell Norfolk Charity requires two representatives from Nordelph Parish Council but currently only has one. It was resolved with all in favour to elect Councillor Stannard as a representative from Nordelph Parish Council onto this *charity*. Clerk to inform the Clerk for Upwell Norfolk Charity.

### 16. War Memorial

16.1 The stonemason is due to return to complete the lettering to the memorial. On going.
